



## Kentucky Organization of Nurse Leaders New Membership & Membership Renewal Application

*KONL, formerly known as KONE, is a statewide organization affiliated with the Kentucky Hospital Association*

- Provides a medium for the interchange of ideas and dissemination of information and materials relative to Nursing Leadership.
- Provides a platform within health care from which Nursing Leaders may speak.
- Provides leadership development.
- Participates in the formulation of public policies that influence health care.
- Provides a system of networking and support for members.

### Meetings

District meetings and educational programs are held at various locations throughout the State during the year. Other meetings may be scheduled as needs and issues develop. A business meeting is held for all members during the annual KHA meeting in the Spring and a Leadership Development Conference including poster presentation is held in the Fall.

### Membership

You are eligible for membership if you meet one of the following criteria:

**Full Members:** Individuals eligible to be members in the Organization shall be registered nurses who are nurse leaders in all health care organizations. Full members shall be: registered nurses holding positions such as chief nursing officer/chief nurse executive, vice president of nursing and patient care services, director of nursing, director of emergency services, critical care services and other clinical departments, director of professional practice, nurse manager, nurse consultant, dean and faculty in undergraduate and graduate nursing programs and many other nursing leadership professionals as well as KONL members who are retired.

**Associate Members:** Registered nurses who are not eligible to be full KONL members but are students enrolled in a relevant degree program with a career path in nursing administration or aspiring nursing leaders with a letter of recommendation from a full member may be Associate members. Associate members are non-voting members who are eligible to attend member meetings and may utilize member discounts to KONL programs. Recommendations for associate membership shall be approved by the KONL board of director.

### Dues

If you meet the above requirements, complete and return the attached membership application. Dues for members/associates are **\$50.00 per year**. This will provide membership for 12 months following dues payment.
